INSTRUCTIONS FOR ELECTRONIC NAME/ADDRESS SUBMISSION

If you are a broker or other nominee for a beneficial owner who purchased or otherwise acquired publicly traded securities of General Motors Corp. (GM), during the period between April 13, 2000 and March 30, 2006, inclusive, and who suffered damages thereby, including all persons and entities who acquired shares of GM common stock and preferred stock in the secondary market, all persons or entities who acquired debt securities of GM in the secondary market or pursuant to a registration statement or prospectus, and all persons who purchased or wrote (sold) exchange-traded options on GM common stock, please use the spreadsheet format for the electronic name/address submission provided at the end of this form or on the website to submit the names/addresses of your clients to the Claims Administrator. Upon receipt of the properly formatted spreadsheet, the Claims Administrator will mail the Notice and Proof of Claim form to the names/addresses provided.

Instructions

Please supply the data in Excel format on a CD or floppy diskette using the electronic file layout described below. You must mail your completed spreadsheet to the Claims Administrator within 7 (seven) days of receiving the Nominee Election Letter to the address below:

B	Address Line 1	60	Address lines are used to indicate the owner(s) of the securities and their mailing address.  Example: Address line 1: John Smith Address Line 2: 123 W 5 <sup>th</sup> St Address line 3: Seattle, WA 01023

Note: Columns should contain no more characters than specified above. Please make appropriate abbreviations if necessary. If you download the spreadsheet provided on this website, a warning message will appear when information keyed into a column exceeds the field length. If information is pasted into a column, no warning message will appear, but the cell color will change to yellow to alert you that field length has been exceeded.

**IMPORTANT NOTE:**

Each row of the spreadsheet should include mailing information for a single potential claimant and account. If the listed beneficial owner has more than one account, you must provide the personal information separately for each account. For example, you cannot combine both individual and joint account information under the same account number. In this situation, you should enter all information regarding the individual account first; then, on a separate line, enter the information regarding the joint account.
